#### 8. Confirmation of Auditors 2021/2022

John Gerner informed the meeting that the Club has asked auditors of the previous year's accounts to continue so notification of confirmation has already been made.

Tim Clarke (present Treasurer) reported that money is still accumulating due to the large increase in membership and the usual routine payments have been made. The Section and Areas need to look at how to spend this extra funding.

#### 9. Venue for 2022 section AGM and FoWC

This was scheduled for Wessex to host, however Peakland have offered as they did not do it this year, therefore Wessex will host 2023.

Yvonne Plevey gave details of the venue which is to be Matlock Rugby Club at Cromford, Derbyshire A large flat field and hall is included in the price (hall seats 100 in normal times).

## 10. Any other business

The 2021 AGM at Settle is being organised by the Section, Andrew Wood is stewarding and reported that Margaret Allen has done the booking and a hall is available. He is pleased that members from Peakland and Margaret Allen from Northern have volunteered to help and he will investigate if these helpers can camp a day earlier for marking out etc. Andrew outlined additional costs – hire of hall, skip hire, elsan disposal, bin bags etc. Deb Masters proposed that a subcommittee be formed to discuss this and all accounts and receipts and verify site fees. As it is a THS we may get non-W&CS members. At this time, no entertainment has been arranged due to the present situation. In the past a raffle has been organised to offset the cost, this will be discussed when the sub-committee report to the Council meeting in early January. Andrew Wood, Barry Cowlard, Sandra Wain, Christine Mason, Howard and Anne Crosland volunteered to be on the subcommittee and Barry Cowlard agreed to convene a meeting.

New flags and banners – The Communications Committee has approved the designs and they have been sent to all Committee members. John Gerner reported the options and costs of these. He will send information to the Areas to decide which option they prefer. There is plenty of time for agreement as it is some time until the new season. Trev Masters suggested that there be a Section flag, John Gerner confirmed that this could be done but no Area name on them. The cost would be the same as Area flags.

The Chairman thanked John Gerner for the work undertaken on the new flags.

Membership numbers. – The membership secretary received notification of 33 new joiners yesterday, however because of the three-month extension overall membership numbers have dropped one thousand, He has contacted the Club HQ and they say there is nothing to worry about, money is still coming in. The Chairman commented that these increased numbers give us an opportunity to welcome people to our Section.
